The Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the Amended Implementing Rules and Regulations (A-IRR) of the Republic Act No. 9184, otherwise known as the “Government Procurement Reform Act”.

It may also be downloaded from the website of the PhilGEPS and the website of the Procuring Entity provided that the contractors shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
