



### INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Air Transportation Office (ATO), invites all prospective bidders to apply for eligibility and subsequently bid for the:

Source of Funds	:	RA9336 (CY2005)
Contract Duration	:	One Hundred Twenty (120) Calendar days
Required Equipment	:	Bulldozers (2), Pay Loaders (2), Dump Trucks (4), Road Grader (1) and Vibratory Roller (1) Note: equipment must be supported by proof/s of ownership, leased, and/or under purchase agreements and Certification of availability of equipment for the duration of the project.

The BAC will conduct the public bidding in accordance with R. A. 9184 and its Implementing Rules and Regulations Part A.

To be eligible to bid, contractors should possess a valid PCAB License applicable to the type and cost, have complete a similar contract with a value of at least 50 percent of the ABC and have key personnel and equipment available for the prosecution of the contract. The ATO will use non-discretionary pass/fail criteria in the eligibility check as well as the preliminary examination of bids. The BAC will conduct post-qualification of the lowest calculated bid.

The BAC will issue to prospective bidders Eligibility Forms at the BAC Secretariat, Ground Floor, ATO Main Building, MIA Road, Pasay City, upon submission of LOI and payment of a non-refundable amount of ₱ 500.00 to the ATO. Prospective bidders shall submit the Eligibility Requirements to the BAC and may also obtain the results of the Eligibility Check at the same address.

Bidding Documents will be issued only to bidders declared by the BAC to be eligible for the bidding and upon payment of a non-refundable amount of ₱ 6,500.00.

The ATO reserves the right to accept or reject any bid and to annul the bidding process anytime before the Contract award, without incurring any liability to the affected Bidders.
