



INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

12 November 2008

The Civil Aviation Authority of the Philippines (CAAP), through its Bids and Awards Committee (BAC), invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible, to bid for the hereunder project / contract:

Name of Project : **Establishment of Aeronautical Information Service Automation**
Location : Manila Airways Facilities Complex, CAAP Compound, MIA Road, Pasay City
Brief Description : Supply and Installation of Aeronautical Communications and Automation
Source of Fund : ANF Infra CY 2008
Approved Budget for the Contract (ABC): Php 50,000,000.00
Contract Duration : Ninety (90) calendar days

Minimum Requirements:

Prospective bidders should possess a valid PCAB License with at least Category "B" Classification on Communication Facilities and Navigational Facilities, have completed a similar aeronautical communications contract with a value of at least 50% of the ABC with same in nature and complexity, have key personnel and equipment listed in the Eligibility Documents and Eligibility Data Sheet. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check / Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Republic Act 9184 (R.A. 9184) and its Implementing Rules and Regulation (IRR-A) and is restricted, unless otherwise stated, to organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines. In accordance with the IRR-A of R.A 9184, only Bids from eligible Bidders will be opened. In accordance with the IRR-A of R.A. 9184 a contract will only be awarded to the Lowest Calculated and Responsive Bidder who was determined as such during post-qualification.

The BAC will issue to prospective bidders Eligibility Forms at BAC Office, CAAP, MIA Road, Pasay City, Metro Manila 1300 upon their submission of an LOI, PCAB License and payment of a non-refundable amount of Php 10,000.00 to the CAAP Cashier. Prospective bidders shall submit the Eligibility Requirements to the BAC at the said address. They may also obtain the results of the Eligibility Check by the BAC at the same address. The BAC will issue Bidding Documents only to bidders declared by the BAC to be eligible for the bidding upon payment of a non-refundable amount of Php 25,000.00 CAAP Cashier.

The CAAP reserves the right to reject bid and/or all bids, to waive defects or formality therein and to accept bids considered responsive and most advantageous to the Government, and assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
