



INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Air Transportation Office (ATO), through its Bids and Awards Committee (BAC) invites prospective bidders to apply for eligibility and if found eligible, to bid the hereunder projects:

Prospective bidders must have completed a contract of the same in nature with a value of at least 50% of the project to be bid and meet the other minimum eligibility requirements stated in the Eligibility Documents.

All particulars relative to the eligibility statement and screening, bid security, performance security, pre-bidding conference, evaluation of bids, post qualification and award of contract shall be governed by the pertinent provision of R. A. 9184 and its Implementing Rules and Regulations Part A (IRR-A). Contract will only be awarded to the Lowest Calculated and Responsive Bidder who was determined as such during the post-qualification.

Prospective bidders shall submit the Eligibility Requirements and Bidding Documents to the BAC at the said address.

The ATO reserves the right to reject bid and/or all bids, to waive defects or formality therein and to accept bids considered responsive and most advantageous to the Government, and assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
