This Supplemental/Bid Bulletin No. 2 is issued to modify, amend or clarify items in the Bidding Documents for the **PROCUREMENT OF SECURITY SERVICES REQUIREMENTS FOR CAAP AREA CENTER XI (Davao International Airport, General Santos Airport and Cotahato Airport)** for **CY 2017 to 2019**:

The modifications, amendments or clarifications are as follows:

- 1.) The Prospective Bidder's must submit Philippine Government Electronic Procurement System (PhilGEPS) Certificate of Registration (**Platinum Membership**).

For Prospective Bidder's without PhilGEPS Certificate of Registration (Platinum Membership), the following Class "A" Eligibility Documents must be submitted:

- ~~(a) Registration Certificate from Securities and Exchange Commission (SEC)~~ or Department of Trade and Industry (DTI) for sole proprietorship, or Cooperative Development Authority (CDA) for cooperatives;
 - Certificate of Incorporation or Article of Incorporation or Amended Articles of Incorporation shall be accepted in lieu of the SEC Registration Certificate.
- (b) Mayor's/Business Permit issued by the City or Municipality where the principal place of business of the prospective bidder is located, or the equivalent document for Exclusive Economic Zones or Areas;
- (c) Tax Clearance per E.O. 398, s. 2005, as finally reviewed and approved by the Bureau of Internal Revenue (BIR).

Bids not complying with the above instruction shall be disqualified.

- 2.) Amendments for Checklist of Bidding Document (Annex "A") of Section VIII. Bidding Forms & Format. Please see attached revised Annex "A".
- 3.) For Contract Agreement Form (Annex "B") of Section VIII. Bidding Forms & Format, the form should be deleted and excluded in the Technical Component.
- 4.) For the Bill of Quantities (Annex "Z") of Section VIII. Bidding Forms & Format, the computation for PADPAO Cost Distribution Per Month for **Item A. Amount Due to Guard** and **Item B. Amount Due to Government in favor of the Guard** shall be based on the computation issued by Philippine Association of Detective and Protective Agency Operators (PADPAO), Inc., Head Office located at No. 13,

3rd Avenue, Brgy. Bagong Lipunan ng Crame, Cubao, Quezon City. Subsequently, for **Item D. Administrative Overhead and Margin** the computation must conform to the DOLE Department Order No. 150-16, Series of 2016.

5.) Amendments for ITB Clause 12.1(a)(ii) of Section III. Bid Data Sheet.

Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid in accordance with ITB Clause 5.4. The SLCC shall be equivalent to at least Fifty Percent (50%) of the ABC and completed within the last Five (5) years.
	The Two (2) above Statement shall include all information required in ITB Clause 12.1(a)(ii).
