**INVITATION TO BID FOR  
PURCHASE/INSTALLATION OF PAPI SYSTEM & AERODROME  
BEACON AT CAUAYAN AIRPORT.  
BID NO 17-014-04**

1. The **Civil Aviation Authority of the Philippines**, through the **CAAP Corporate Budget for CY 2017** intends to apply the sum of **FIFTEEN MILLION ONE HUNDRED FORTY ONE THOUSAND THREE HUNDRED PESOS ONLY (Php15,141,300.00)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for the **PURCHASE/INSTALLATION OF PAPI SYSTEM & AERODROME BEACON AT CAUAYAN AIRPORT**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Civil Aviation Authority of the Philippines (CAAP)** now invites bids for the **SUPPLY AND DELIVERY, INSTALLATION AND COMMISSIONING OF PAPI SYSTEM & AERODROME BEACON AT CAUAYAN AIRPORT**. Completion of work (Delivery of Goods and Installation) is required within **ONE HUNDRED TWENTY (120) CALENDAR DAYS** upon receipt of the **Notice to Proceed**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from **Civil Aviation Authority of the Philippines (CAAP)** and inspect the Bidding Documents at the address given below during office hours from 8:00AM to 5:00PM.

A complete set of Bidding Documents may be acquired by interested Bidders on **April 4, 2017 to April 25, 2017** from the address below and upon payment of a nonrefundable fee for the Bidding Documents pursuant to the latest guidelines issued by the GPPB in the amount of **TWENTY FIVE THOUSAND PESOS ONLY (Php 25,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

5. The Civil Aviation Authority of the Philippines will hold a Pre-Bid Conference on **April 11, 2017 @ 10:00AM** at CAAP Conference Room, CAAP Compound, Old MIA Road Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila, which shall be open to prospective bidders.


6. Bids must be delivered to the address below on or before **April 25, 2017. 2:00PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **2:00PM of April 25, 2017** at the Civil Aviation Authority of the Philippines Conference Room, CAAP Compound, Old MIA Road, Pasay City, MM 1300. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The **Civil Aviation Authority of the Philippines** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
