



Section I. Invitation to Bid

SUPPLY, INSTALLATION AND TESTING OF AERODROME TOWER SIMULATOR BID NO 17-016-04

1. The Civil Aviation Authority of the Philippines (CAAP), through the Corporate Budget of 2017, intends to apply the sum of “One Hundred Million Pesos” (Php100,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for “Supply, Installation and Testing of Aerodrome Tower Simulator”. Bids received in excess of the ABC shall automatically be rejected at bid opening.
2. The CAAP through the Bids and Awards Committee (BAC) now invites bidders for the Supply, Installation and Testing of Aerodrome Tower Simulator. Bidders should have completed, within five (5) years from the date submission and receipt of bids, one (1) similar to the Project. Delivery of the Goods must be completed within one hundred eighty calendar days (180cd) from receipt of Notice to Proceed (NTP). The description of an eligible bidder is contained in the Bidding Documents, particularly Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all bidders, whether local or foreign, subject to the conditions for eligibility provided in the revised IRR of R.A. 9184.

4. Interested Bidders may obtain further information from the CAAP BAC Secretariat and inspect the Bidding Documents at BAC Secretariat, Civil Aviation Authority of the Philippines, Old MIA Road, Pasay City during office hours from 8:00 AM to 5:00 PM.

5. A complete set of Bidding Documents may be acquired by interested Bidders on April 20 to May 11, 2017 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifty Thousand pesos (Php50,000.00) except for bidders who bought the Bidding Document and participated during the previous bidding of the project.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of CAAP, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The CAAP will hold the Pre-bid conference on April 27, 2017, 2:00 PM at the CAAP Conference Room, which shall be open to all bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before May 11, 2017 @ 2:00PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on May 11, 2017 @ 2:00PM at CAAP Conference Room, MIA road, Pasay City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Civil Aviation Authority of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


