The Civil Aviation Authority of the Philippines (CAAP), through its Corporate Operating Budget (COB) for CY 2017 intends to apply the sum of **Fourteen Million Three Hundred Nine Thousand Five Hundred Twenty Pesos (Php14,309,520.00) (For the First Year only)**, inclusive of VAT, being the Approved Budget for the Contract (ABC) to payment under the contract for the **PROVISION OF SECURITY SERVICES REQUIREMENTS FOR CAAP AREA CENTER I (Laoag International Airport, Vigan Airport, Lingayen Airport, Baguio Airport and Bacnotan VOR Station, La Union)**.
