Invitation to Bid for *CONSTRUCTION OF POWER HOUSE AT ROMBLON AIRPORT*

1. The *CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP) BIDS AND AWARDS COMMITTEE*, through the CAAP Corporate Budget CY 2017¹ intends to apply the sum of **TWO MILLION PESOS** (Php2,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for **CONSTRUCTION OF POWER HOUSE AT ROMBLON AIRPORT**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP) BIDS AND AWARDS COMMITTEE* now invites bids for the **CONSTRUCTION OF POWER HOUSE AT ROMBLON AIRPORT** Completion of the Works is required for One Hundred Eighty (180) Calendar Days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Civil Aviation Authority of the Philippines, Plaridel Bulacan and inspect the Bidding Documents at the address given below from 8am – 5pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on November 9, 2017 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 2,000.00

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Civil Aviation Authority of the Philippines will hold a Pre-Bid Conference² on November 16, 2017, 9:00am at Plaridel Airport Lumangbayan, Plaridel Bulacan, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *December 1, 2017, 5:00pm*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on December 4, 2017, 9:00am at Plaridel Airport Lumangbayan, Plaridel Bulacan. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.


8. Secure a site inspection certificate duly signed by Airport Manager or his/her representative.
9. The Civil Aviation Authority of the Philippines reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract
