



Invitation to Bid for

CONSTRUCTION OF SEWAGE TREATMENT PLANT, RAINWATER COLLECTION SYSTEM AND PUMP HOUSE (2 UNITS) AT GENERAL SANTOS INTERNATIONAL AIRPORT (RE-BID)

Bid No. 18-045-06

1. The Civil Aviation Authority of the Philippines, through the funds from the DOTr Downloaded Infrastructure Projects intends to apply the sum of **TWELVE MILLION SIX HUNDRED SEVENTY FIVE THOUSAND THREE HUNDRED FIFTY SEVEN PESOS & 66/100 (PhP12, 675, 357.66)** being the Approved Budget for the Contract (ABC) to payments under the contract for **CONSTRUCTION OF SEWAGE TREATMENT PLANT, RAINWATER COLLECTION SYSTEM AND PUMP HOUSE (2 UNITS) AT GENERAL SANTOS INTERNATIONAL AIRPORT (RE-BID) (Bid No.18-045-06)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Civil Aviation Authority of the Philippines now invites bids for **CONSTRUCTION OF SEWAGE TREATMENT PLANT, RAINWATER COLLECTION SYSTEM AND PUMP HOUSE (2 UNITS) AT GENERAL SANTOS INTERNATIONAL AIRPORT (RE-BID)**.

Prospective Bidders should possess the following:

Completion of the Works is required **One Hundred Eighty (180) Calendar Days (inclusive of twenty six (26) rainy/ unworkable days)**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from BAC Office, CAAP Compound, MIA Road corner Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila on **October 18, 2018 to until the deadline of submission of bids** and inspect the Bidding Documents at the address given below from 08:00 AM to 05:00 PM from MONDAY to FRIDAY.

5. A complete set of Bidding Documents may be acquired by interested bidders **October 18, 2018 to until the deadline of submission of bids** from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php25,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Civil Aviation Authority of the Philippines will hold a Pre-Bid Conference on **October 25, 2018 @ 2:00PM** at CAAP Conference Room, CAAP Compound, MIA Road Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila, which shall be open to prospective bidders.



Bids must be duly received by the BAC Secretariat at the address below on or before **November 13, 2018 @ 2:00PM** at BAC Office, CAAP Compound, MIA Road corner Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **November 13, 2018 @ 2:00PM** at CAAP Conference Room, CAAP Compound, MIA Road Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Civil Aviation Authority of the Philippines reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
