The Civil Aviation Authority of the Philippines, through the CAAP Corporate Budget CY 2019 intends to apply the sum of NINETY SEVEN MILLION NINE HUNDRED TWENTY-NINE THOUSAND SIX HUNDRED FORTY-FOUR & 48/100 (PhP 97,929, 644.48) being the Approved Budget for the Contract (ABC) to payments under the contract for CONTINUATION OF ASPHALT OVERLAY OF RUNWAY AT BUTUAN AIRPORT (RE-BID) (Bid No. 19-025-06 ALPHA). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Civil Aviation Authority of the Philippines now invites bids for CONTINUATION OF ASPHALT OVERLAY OF RUNWAY AT BUTUAN AIRPORT (RE-BID).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be acquired by interested bidders on June 05, 2019 until deadline of submission of bid from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 50,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bids must be duly received by the BAC Secretariat at the address below on or before **July 02, 2019 @ 2:00PM** at BAC Office, CAAP Compound, MIA Road corner Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **July 02, 2019** @ **2:00PM** at CAAP Conference Room, CAAP Compound, MIA Road Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
