BAC Resolution No. 2025-0311-43 (Bravo)

SUBJECT: **RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT** ENTITLED PROVISION OF MEALS FOR BAC AND CCC MEETINGS FOR CALENDAR YEAR 2025 (RE-BID) (FRAMEWORK AGREEMENT)

WHEREAS, in a BAC Resolution No. 2025-0311-18 dated 25 April 2025, The Bids and Awards Committee-Bravo declared the bidding for the project a failure. A copy of BAC Resolution No. 2025-0311-18 is herein attached and made an integral part of this Resolution as Annex "A":

WHEREAS, the Invitation to Bid (ITB) was posted on 29 April 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as Annex "B";

WHEREAS, Pre-bid Conference was conducted on 07 May 2025 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as Annex "C";

WHEREAS, on 21 May 2025, during the Submission and Opening of Bids at the BAC Bravo meeting, the BAC members and TWG declared a bidding failure under Section 35.1 (a) of the Revised Implementing Rules and Regulations of Republic Act 9184, considering that no bidders submitted their bid and the procurement of the project be done through Negotiated Procurement for having two failed biddings. A copy of the Minutes of Meeting is hereto attached as Annex "D";

WHEREAS, Section 35.1 (a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: "The BAC shall declare the bidding a failure when no bids are received";

NOW THEREFORE, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby RESOLVED to recommend that the project, Provision of Meals for BAC and CCC Meetings for Calendar Year 2025 (Re-Bid) (Framework Agreement), be declared a FAILURE and to return the bid documents to the end-user for mandatory review;
