



*BAC Resolution No. 2025-0311-29 (Alpha)*

**SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, REHABILITATION OF POWER HOUSE AND SUPPLY, DELIVERY, AND INSTALLATION OF GENERATOR SET AT BASCO AIRPORT.  
(Bid No. 25-12-03 Alpha)**

**WHEREAS**, the project Rehabilitation of Power House and Supply, Delivery, and Installation of Generator Set at Basco Airport, an ADMS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Two Million Three Hundred Eleven Thousand Five Hundred Fourteen Pesos and 42/100 (PHP2,311,514.42). A Copy of the Certificate of Budget Allocation (CBA (CO) No. 25-02-171) dated 05 February 2025 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 04 March 2025 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 11 March 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, the Pre-Bid Conference was conducted on 18 March 2025 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

**WHEREAS**, the committee issued a Bid Bulletin No. 01 dated 24 March 2025, rescheduling the Pre-Bid Conference and Submission and Opening of Bids of this project. A copy of Bid Bulletin No. 01 is hereto attached as *Annex "E"*;

**WHEREAS**, the Submission and Opening of Bids for the project was held on 03 April 2025 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "F" & "G"*, respectively;

**WHEREAS**, the Bids and Awards Committee - Technical Working Group (BAC-TWG Alpha) issued its Bid Evaluation Report dated 08 April 2025 and was presented to the BAC on the same day, where it is indicated that the calculated bid proposal of J.F. Gabotero, Inc. is hereby recommended to be declared as the Single Calculated Bid (SCB) and that Post



Qualification evaluation be conducted to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of the said Report and Minutes of Meeting are hereto attached as Annexes "H" & "I", respectively;

**WHEREAS**, the committee issued a letter to J.F. Gabotero, Inc. dated 08 April 2025, requiring the same to submit the necessary additional requirements for post-qualification. A copy of the said letter is hereto attached as Annex "J";

**WHEREAS**, the BAC - TWG (Alpha) issued its Post-Qualification Report dated 06 May 2025 and was presented to the BAC on the same day, wherein the BAC-TWG (Alpha) recommends that the bid proposal of J.F. Gabotero, Inc. be declared as the Single Calculated and Responsive Bid (SCRB) and that the contract be awarded to the bidder for the project: Rehabilitation of Power House and Supply, Delivery, and Installation of Generator Set at Basco Airport in the amount of Two Million One Hundred Ninety-Four Thousand Five Hundred Sixty Pesos & 20/100 (PHP2,194,560.20). The copies of the said Report and Minutes of Meeting are hereto attached as Annexes "K" & "L", respectively;

**WHEREAS**, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed;*

**NOW, THEREFORE**, premises considered, the **CAAP-BAC RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **Rehabilitation of Power House and Supply, Delivery, and Installation of Generator Set at Basco Airport** in the total amount of Two Million One Hundred Ninety-Four Thousand Five Hundred Sixty Pesos & 20/100 (PHP2,194,560.20) to **J.F. Gabotero, Inc.**


