BAC Resolution No. 2025-0311-31 (Alpha)

SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, PURCHASE/INSTALLATION OF DIESEL ENGINE GENERATOR SET (DEGS) AT ZAMBOANGA AIRPORT (Bid No. 25-13-03 ALPHA)

WHEREAS, the project Purchase/Installation of Diesel Engine Generator Set (DEGS) at Zamboanga Airport, an ANS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Thirteen Million Two Hundred Forty-Six Thousand Two Hundred Ten Pesos (PHP13,246,210.00). A copy of the Certificate of Budget Allocation (CBA (CO) No. 25-02-176) dated 05 February 2025 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 06 March 2025 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 10 March 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C*";

WHEREAS, the committee issued a Bid Bulletin No. 01 dated 24 March 2025, which contained the new schedule for Pre-Bid Conference and Submission & Opening of Bids for this project. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "D"*;

WHEREAS, the committee issued a Bid Bulletins No. 01 and 02 dated 02 April 2025, the former of which contained a response to the queries/clarifications of the bidders and the latter of which included a new schedule for the Pre-Bid Conference and Submission and Opening of the Bids. The copies of the Bid Bulletins are hereto attached as *Annex "E"*;

WHEREAS, the Pre-Bid Conference was conducted on 18 March 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "F"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 10 April 2025 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "G" & "H"*, *respectively*;

WHEREAS, the Bids and Awards Committee - Technical Working Group (BAC-TWG Alpha) issued its Bid Evaluation Report dated 15 April 2025 and was presented to the BAC on 24 April 2025, where it is indicated that the calculated bid proposal of Gendiesel Philippines, Inc. is hereby recommended to be declared as the Single Calculated Bid (SCB) and that Post Qualification evaluation be conducted to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of the said Report and Minutes of Meeting are hereto attached as Annexes "I" & "J", respectively;

WHEREAS, the committee issued a letter to Gendiesel Philippines, Inc. dated 24 April 2025, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as Annex "K";

WHEREAS, the BAC-TWG (Alpha) issued its Post-Qualification Report dated 08 May 2025 and was presented to the BAC on the same day, wherein the BAC-TWG (Alpha) recommends the Post-Disqualification of Gendiesel Philippines, Inc. for failure to declare all on-going government and private projects. It was also recommended to declare the failure of bidding for this project and the recommendation was adopted by the committee. The copies of the said Report and Minutes of Meeting are hereto attached as Annexes "L" & "M", respectively;

WHEREAS, the committee issued a Notice of Post-Disqualification to Gendiesel Philippines, Inc. dated 20 May 2025. A copy of the Notice of Post-Disqualification is hereto attached as Annex "N":

WHEREAS, Section 35.1 (c) of the Revised Implementing Rules and Regulations of RA 9184 provides that: "The BAC shall declare the bidding a failure when all bids fail to comply with all the bid requirements or fail post-qualification, or in the case of Consulting Services, there is no successful negotiation";

NOW THEREFORE, the CAAP-BAC ALPHA acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby RESOLVED to recommend that the project, PURCHASE/INSTALLATION OF DIESEL ENGINE GENERATOR SET (DEGS) AT ZAMBOANGA AIRPORT be declared a FAILURE and to return the bid documents to the end-user for mandatory review.
