SUBJECT:

RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, PURCHASE/INSTALLATION OF APAPI SYSTEM AND OTHER WORKS AT BAGUIO AIRPORT (Bid No. 25-18-03 Alpha)

WHEREAS, the project Purchase/Installation of APAPI System and other Works at Baguio Airport, an ANS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Twenty-One Million Seven Hundred Eighty-Six Thousand Nine Hundred Thirty-Nine Pesos & 45/100 (PHP21,786,939.45). A copy of the Certificate of Budget Allocation (CBA (CO) No. 25-02-254) dated 18 February 2025 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 20 March 2025 via in person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 26 March 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, the Pre-Bid Conference was conducted on 03 April 2025 via in person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 15 April 2025 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "E" & "F", respectively;*

WHEREAS, the Bids and Awards Committee - Technical Working Group (BAC-TWG Alpha) issued its Bid Evaluation Report dated 15 April 2025 and was presented to the BAC on 24 April 2025, where it is indicated that the calculated bid proposal of Evercon Builders and Equipment Corporation is hereby recommended to be declared as the Single Calculated Bid (SCB) and that Post Qualification evaluation be conducted to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. WHEREAS, the committee issued a letter to Evercon Builders and Equipment Corporation dated 24 April 2025, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "I"*,

WHEREAS, the BAC - TWG (Alpha) issued its Post-Qualification Report dated 08 May 2025 and was presented to the BAC on the same day, wherein the BAC-TWG (Alpha) recommends that the bid proposal of Evercon Builders and Equipment Corporation be declared as the Single Calculated and Responsive Bid (SCRB) and that the contract be awarded to the bidder for the project: Purchase/Installation of APAPI System and other Works at Baguio Airport in the amount of Twenty One Million Five Hundred Eighty Eight Thousand Eight Hundred Thirty Pesos & 45/100 (PHP21,588,830.45). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "J" & "K"*, respectively;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend* to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed;

NOW, THEREFORE, premises considered, the CAAP-BAC RESOLVES, as it is hereby RESOLVED to recommend the APPROVAL and AWARD of the project, Purchase/Installation of APAPI System and other Works At Baguio Airport in the total amount of Twenty One Million Five Hundred Eighty Eight Thousand Eight Hundred Thirty Pesos & 45/100 (PHP21,588,830.45) to Evercon Builders and Equipment Corporation.
