

BAC RESOLUTION NO. 2025-0515-105 (BRAVO)

RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SUPPLY AND **DELIVERY OF HIGH-SPEED SCANNERS FOR VARIOUS CAAP OFFICES**

WHEREAS, the project, Supply and Delivery of High-Speed Scanners for Various CAAP Offices, an ODG-ITD project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Three Million Four Hundred Thousand Pesos (PHP3,400,000.00). WHEREAS, the Submission and Opening of bids for the project was held on 21 May 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project and the following results were noted. WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Post-Qualification Report dated 27 June 2025 and was presented to the BAC on the same day, wherein the Committee recommended that the bid proposal of Patronics International Corp. be declared as the Lowest Calculated & Responsive Bid (LCRB) and that the contract be awarded to the bidder in the amount of One Million Three Hundred Twenty-Five Thousand Six Hundred Pesos (PHP1,325,660.00).
