



BAC Resolution No. 2025-0515-61 (Bravo)

**SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, TESTING AND COMMISSIONING OF CCTV SURVEILLANCE SYSTEM FOR VARIOUS AIRPORTS (9 SITES)**

**WHEREAS**, the project, Supply, Delivery, Installation, Configuration, Testing and Commissioning of CCTV Surveillance System for Various Airports (9 Sites), an CSIS project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Forty-Two Million Four Hundred Twenty-Two Thousand Nine Hundred Forty-Two Pesos & 23/100 (PHP42,422,942.23). A copy of the Certificate of Budget Allocation CBA (CO) No. 25-01-135 dated 31 January 2025 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 21 April 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 02 May 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, the Pre-Bid Conference was conducted on 09 May 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on 21 May 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F", respectively*;

**WHEREAS**, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 28 May 2025. On the same date, the BAC-Bravo TWG presented its report indicating that where it is indicated that the calculated bid proposal of Annex Digital Inc. is hereby recommended to undergo Post-Qualification process for being evaluated and considered as the Lowest Calculated Bid (LCB). **WHEREAS**, the Committee issued a letter to Annex Digital Inc. dated 28 May 2025, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "I"*;

**WHEREAS**, the Committee issued its Post-Qualification Report dated 11 June 2025 and was presented to the BAC on the same day, wherein the Committee recommended that the bid proposal of Annex Digital Inc. be declared as the Lowest Calculated & Responsive Bid (LCRB) and that the contract be awarded to the bidder in the amount of Forty-Two Million Four Hundred Eight Thousand Pesos (PHP42,408,000.00). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "J" & "K", respectively*;

**NOW, THEREFORE**, premises considered, the **CAAP-BAC (BRAVO) RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **Supply, Delivery, Installation, Configuration, Testing and Commissioning of CCTV Surveillance System for Various Airports (9 Sites)** in the total amount of **Forty-Two Million Four Hundred Eight Thousand Pesos (PHP42,408,000.00)** to **Annex Digital Inc.**


