

BAC Resolution No. 2025-0515-73 (Bravo)

SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, SUPPLY AND DELIVERY OF OSCILLOSCOPE DME TEST EQUIPMENT AND PULSE POWER SENSOR FOR ANS TECHNICAL CENTER

WHEREAS, the project, Supply and Delivery of Oscilloscope DME Test Equipment and Pulse Power Sensor for ANS Technical Center, an ANS project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Five Million Pesos (PHP5,000,000.00). A copy of the Certificate of Budget Allocation CBA (CO) NO.: 25-02-290 dated 26 February 2025 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 30 April 2025 via inperson meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 09 May 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C*";

WHEREAS, the Pre-bid Conference was conducted on 16 May 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 28 May 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted its bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F"*, respectively;

WHEREAS, the Committee received a Motion for Reconsideration from Rohde & Scwarz (Philippines) Inc. dated 28 May 2025, stating that the reason for the expired Audited Financial Statement in their PhilGEPS registration Certificate is due to the fact that their fiscal year for filing is different from the Calendar Year. A copy of their Motion for Reconsideration is hereto attached as *Annex "G"*;

WHEREAS, during the BAC-Bravo regular meeting dated 30 May 2025, the committee discussed the Motion for Reconsideration of Rohde & Schwarz (Philippines) Inc., wherein upon review of the submitted documents of the disqualified bidder the committee decided to grant their Motion for Reconsideration. A copy of the Minutes of Meeting is hereto attached as *Annex "H"*;

WHEREAS, the Re-Opening of Bids for the project was held on 11 June 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. The bid proposal of Rohde & Schwarz (Philippines) Inc. was re-opened, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "I" & "J"*, respectively;

WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 13 June 2025. On the same date, the BAC-Bravo TWG presented its report where it is indicated that the bid proposal of Rohde & Schwarz (Philippines) Inc.be disqualified for their failure to itemized the cost of every item listed in the schedule of requirements. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "K" & "L", respectively;*

WHEREAS, the BAC-TWG Bravo recommended for declaration of failure of bidding being there is only one bidder for the project which was disqualified, the recommendation was then adopted by the Committee in accordance to Section 35 (c) of the Revised Implementing Rules and Regulation of RA 9184;

WHEREAS, Section 35(c) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when: c) All Bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation;"*

NOW THEREFORE, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby **RESOLVED** to recommend that the project, **Supply and Delivery of Oscilloscope DME Test Equipment and Pulse Power Sensor for ANS Technical Center** be declared a **FAILURE** and to return the bid documents to the end-user for mandatory review;
