



**BAC RESOLUTION NO. 2025-0515-103 (BRAVO)**

**RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SUPPLY AND DELIVERY OF LAPTOPS AND COMPUTERS FOR VARIOUS CAAP OFFICES**

**WHEREAS**, the project, Supply and Delivery of Laptops and Computers for Various CAAP Offices, an ITD project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Twenty-Seven Million Two Hundred Sixty Thousand Pesos (PHP27,260,000.00). A copy of the Certificate of Budget Allocation CBA (CO) No. 25-04-560 dated 28 April 2025 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 14 May 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 28 May 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, the Pre-Bid Conference was conducted on 04 June 2025 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

**WHEREAS**, Bid Bulletin No. 01 was published 11 June 2025 for some clarification/revision/amendments in the bidding documents of the project. A copy of Bid Bulletin No.01 is hereto attached as *Annex "E"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on 18 June 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted their bid proposal for the project and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "F" & "G", respectively*;

**WHEREAS**, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 20 June 2025. On the same date,



the BAC-Bravo TWG presented its report indicating that the calculated bid proposal of Joneco Tech Marketing Corp. in Joint Venture with Idenico Computer Corp. is hereby recommended to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "H" & "I", respectively*;

**WHEREAS**, the Committee issued a letter to Joneco Tech Marketing Corp. in Joint Venture with Idenico Computer Corp. dated 20 June 2025, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "J"*;

**WHEREAS**, the Committee issued its Post-Qualification Report dated 02 July 2025 and was presented to the BAC on the same day, wherein the Committee recommended that the bid proposal of Joneco Tech Marketing Corp. in Joint Venture with Idenico Computer Corp. be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of Twenty-Two Million Five Hundred Thirty-Eight Thousand Four Hundred Four Pesos (PHP22,538,404.00). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "K" & "L", respectively*;

**NOW, THEREFORE**, premises considered, the **CAAP-BAC (BRAVO) RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **Supply and Delivery of Laptops and Computers for Various CAAP Offices** in the total amount of **Twenty-Two Million Five Hundred Thirty-Eight Thousand Four Hundred Four Pesos (PHP22,538,404.00)** to **Joneco Tech Marketing Corp. in Joint Venture with Idenico Computer Corp.**
