The Flight Standards Inspectorate Service, Civil Aviation Authority of the Philippines (CAAP) proposes to amend the Philippine Civil Aviation Regulations (PCAR) Part 9, Section 9.5.1.14, to establish clear conditions for Air Operator Certificate (AOC) holders to perform or approve maintenance, overhaul, modifications, repairs, and inspections without an Approved Maintenance Organization (AMO) certificate.

The proposed amendment allows AOC holders without an AMO certificate to perform and approve maintenance work when the State of Registry grants approval, the activities are included in the maintenance program and operations specifications, and the State of the Operator accepts the arrangement. When outsourcing maintenance, AOC holders must engage a properly rated AMO approved by the State of Registry or by a recognized civil aviation authority.

In addition, return-to-service approvals shall be issued by qualified licensed individuals under the State of Registry. Maintenance of Class I products (aircraft, engines, or propellers) shall be performed only by AMOs authorized by CAAP. For Class II and III products (components or parts), CAAP will accept release certificates from foreign AMOs approved by recognized civil aviation authorities. Foreign AMOs with valid CAAP-issued certificates may continue operating until the expiration of the certificate.

This Authority invites all concerned individuals and stakeholders to review the proposed amendment and submit comments, suggestions, or recommendations using Attachment *B* – *NPRM Response Form* within fifteen (15) days from the issuance of this Memorandum. Submit responses through:

9.4.1.13 AUTHORITY TO PERFORM AND APPROVE MAINTENANCE, OVERHAUL, PREVENTIVE MAINTENANCE AND MODIFICATIONS, REPAIRS, AND INSPECTIONS

(a) An operator shall make arrangements with an appropriately rated AMO for the performance of maintenance, preventive maintenance, or modifications of any aircraft, airframe, aircraft engine, propeller, appliance, or component, or part thereof as provided in the applicable aircraft maintenance program and operator's maintenance control manual. An AOC holder that is not certificated as an AMO may perform maintenance, overhaul, modifications, repairs,

inspections, and approvals for return to service on any aircraft or aeronautical product, if approved by the State of Registry of the aircraft and listed in the operations specifications, as provided in its maintenance program, and accepted by the State of the Operator.

- (b) An AMO may perform maintenance, preventive maintenance, or modifications on any aircraft, airframe, aircraft engine, propeller, appliance, or component, or a part thereof and certify a return to service, if approved in its specific operating provisions, as provided in the applicable aircraft maintenance program and operator's maintenance control manual. An AOC holder may make arrangements with an appropriately rated AMO for the performance of maintenance, overhaul, modifications, repairs, and inspections of any aircraft or aeronautical product as provided in its maintenance program and MCM. The activities listed shall be performed by an AMO approved by the State of Registry or approved by another Authority that is accepted by the State of Registry.
- (c) An AOC holder that is not certificated as an AMO shall use an appropriately licensed and rated person in accordance with Part 2 of these regulations, as appropriate, to approve for return to service any maintenance, overhaul, modifications, repairs, and inspections of any aircraft or aeronautical product after performing or supervising in accordance with technical data approved by the State of Registry. The activities listed shall be performed by a person licensed by the State of Registry.

Note 1: Local and foreign AMOs maintaining Class I products shall be authorized by the Authority.

Note 2: Release certificates issued by foreign AMOs for Class II or Class III products is acceptable to the Authority provided the AMO is approved either by the State of Registry or by another regulatory authority whose approval is recognized and accepted by the State of Registry.

Note 3: Foreign AMOs maintaining Class II and/or Class III products that have been issued a AMO certificate by the Authority may continue to exercise their privileges until the certificate expires.
