The Flight Standards Inspectorate Service, Civil Aviation Authority of the Philippines (CAAP) proposes to amend the note in Philippine Civil Aviation Regulations (PCAR) Part 8: 8.5.1.21(a)(3).

The amendment incorporates additional ICAO guidance material for the procedure for making meteorological observations on board aircraft in flight and for recording and reporting.

PCAR PART 8

8.5.1.21 REPORTING OF HAZARDOUS CONDITIONS

(a) The PIC shall report to the appropriate ATC facility, without delay and with enough details to be pertinent to the safety of other aircraft, any hazardous flight conditions encountered en-route, including those associated with meteorological conditions.

...

(3) Meteorological Observation

Note. – The procedures for making meteorological observations on board aircraft in flight and for recording and reporting them are contained in ICAO Annex 3, the PANS-ATM (ICAO Doc 4444), the PANS-MET (ICAO Doc 10157), and the appropriate Regional Supplementary Procedures (ICAO Doc 7030).
