SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SUPPLY/DELIVERY OF SPARE PARTS FOR SITTI RADIO COMMUNICATION EQUIPMENT FOR VARIOUS ANF'S

WHEREAS, the project, Supply/Delivery of Spare Parts for SITTI Radio Communication Equipment for Various ANF's, an ANS project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Five Million Pesos (PHP5,000,000.00). A copy of the Certificate of Budget Allocation CBA (MOOE) No. 25-04-510 dated 14 April 2025 is herein attached as *Annex "A"*;

WHEREAS, the Committee issued a Notice of Direct Contracting and Request for Quotation dated 13 May 2025 to Evercon Builders & Equipment Corporation. A copy of the Notice of Direct Contracting and Request for Quotation is hereto attached as *Annex "B"*;

WHEREAS, the Submission and Opening of bids for the project was held on 23 May 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. A bidder submitted their bid proposal for the project, and the following results were noted. 
