SUBJECT:

RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, MAINTENANCE/REPLACEMENT OF BATTERIES OF THE TWO (2) UNITS OF 250 KVA LEGRAND UPS AT PHIL.ATMC

WHEREAS, the project, Maintenance/Replacement of Batteries of the Two Units (2) Units of 250 KVA LeGrand UPS at Phil. ATMC, an ANS project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Two Million Eight Hundred Thirty Thousand Pesos (PHP2,830,000.00). WHEREAS, the Committee issued a Notice of Direct Contracting and Request for Quotation dated 23 May 2025 to P2RO, Inc. A copy of the Notice of Direct Contracting and Request for Quotation is hereto attached as Annex "B";

WHEREAS, the Submission and Opening of bids for the project was held on 04 June 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. A bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as Annexes "C" & "D", respectively;

WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 11 June 2025. On the same date, the BAC-Bravo TWG presented its report indicating that P2RO, Inc. was determined legally, technically, and financially capable to deliver the goods at the most advantageous price and contract, under Sec 31.2 of RA 12009. WHEREAS, Section 31.2.b of RA 12009 Direct contracting may only be resorted to in any of the following conditions: b. When the procurement of critical components from a specific manufacturer, supplier or distributor is a condition precedent to hold a service provider to guarantee its project performance, in accordance with the provisions of the contract, as determined by the End-User or Implementing Unit;

NOW THEREFORE, premises considered, the CAAP-BAC BRAVO RESOLVES, as it is hereby RESOLVED to recommend the APPROVAL and AWARD through Direct Contracting of the project, Maintenance/Replacement of Batteries of the Two Units
