**BAC RESOLUTION NO. 2025-0515-104 (ALPHA)**

**RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED,  
CONSTRUCTION OF MATERIAL RECOVERY FACILITY BUILDING (REBID)**

**WHEREAS**, in BAC Resolution No. 2025-0311-26 dated 26 May 2025, the Bids and Awards Committee - Alpha declared the bidding for the project a failure. A copy of BAC Resolution No. 2025-0311-26 is herein attached and made an integral part of this resolution as *Annex "A"*;

**WHEREAS**, the Invitation to Bid (ITB) was posted on 09 June 2025 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "B"*;

**WHEREAS**, Pre-bid Conference was conducted on 17 June 2025 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "C"*;

**WHEREAS**, during the Submission and Opening of Bids on 01 July 2025, there was no bid offer received by the BAC Secretariat, thus the BAC-TWG recommended for the failure of bidding for this project. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

**WHEREAS**, Section 35.1 (a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: "The BAC shall declare the bidding a failure when no bids are received";

**NOW THEREFORE**, premises considered, the **CAAP-BAC (Alpha)**, as it is hereby **RESOLVES** to declare the project, Construction of Material Recovery Facility Building (Rebid) a **FAILURE** and to return the documents to the end-user for mandatory review.
