BAC BRAVO RESOLUTION NO. 2025-0515-113 (BRAVO)

**RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SUPPLY/DELIVERY OF
SPARE PARTS FOR SKYMARU RADIO NAVAIDS EQUIPMENT FOR LAGUINDINGAN &
PUERTO PRINCESA AIRPORTS**

WHEREAS, the project, Supply/Delivery of Spare Parts for Skymaru Radio Navaids Equipment for Laguindingan & Puerto Princesa Airports, an ANS project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Nine Million Nine Hundred Eighty-Seven Thousand Two Hundred Thirty-Seven Pesos & 75/100 (PHP9,987,237.75). A copy of the Certificate of Budget Allocation CBA (MOOE) No. 25-04-521 dated 16 April 2025 is herein attached as *Annex "A"*;

WHEREAS, the Determination/Confirmation of Mode of Procurement was conducted on 23 May 2025 via in-person meeting and Google Meet Video Conference, wherein the end-user requested for the change of mode of procurement of the project from Competitive Bidding to Direct Contracting and after review by the Bids and Awards Committee Technical Working Group (BAC-Bravo TWG) recommended for the change of mode of procurement which the CAAP-BAC Bravo carried. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, BAC Resolution No. 2025-0515-113 dated 23 MAY 2025 was published designating the Technical Working Group assigned for the procurement of this project. A copy of BAC Resolution No. 2025-0515- 113 is hereto attached as *Annex "C"*;

WHEREAS, BAC Resolution No. 2025-0515-45 was published on 19 June 2025, changing the mode of procurement of the project from Competitive Bidding to Direct Contracting. A copy of BAC Resolution No. 2025-0515-45 is hereto attached as *Annex "D"*;

WHEREAS, the Committee issued a Notice of Direct Contracting and Request for Quotation dated 23 June 2025 to Unimasters Conglomeration Inc. A copy of the Notice of Direct Contracting and Request for Quotation is hereto attached as *Annex "E"*;

WHEREAS, the Submission and Opening of bids for the project were held on 02 July 2025 at the CAAP Conference Room via in-person Meeting and Video Conference. A bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "F" & "G", respectively*;

WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 04 July 2025. On the same date, the BAC-Bravo TWG presented its report indicating that Unimasters Conglomeration Inc. was determined legally, technically, and financially capable to deliver the goods at the most advantageous price and contract, under Sec 31.2.c of RA 12009. WHEREAS, Section 31.2.c of RA 12009, *Direct contracting may only be resorted to in any of the following conditions: c. When it is sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the government;*

NOW THEREFORE, premises considered, the **CAAP-BAC BRAVO RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** through **Direct Contracting** of the project, **Supply/Delivery of Spare Parts for Skymaru Radio Nav aids Equipment for Laguindingan & Puerto Princesa Airports** in the total amount of **Nine Million Nine Hundred Thirty Thousand Pesos (PHP9,930,000.00)** to **Unimasters Conglomeration Inc.;**


