



**CCC Resolution No. 2025-013**

**SUBJECT: SUPPLY AND DELIVERY OF HANDHELD TUNABLE RADIO.**

**WHEREAS**, Purchase Request/POW/CBA No. 25-04-487 dated 11 April 2025 for the Supply and Delivery of Handheld Tunable Radio with a total budget of P294,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

**WHEREAS**, on 16 May 2025, the Civil Aviation Authority of the Philippines – Contract and Canvass Committee (CAAP-CCC) resolved to procure this project through Small Value Procurement (SVP) in accordance 34.1 of the Implementing Rules and Regulations (IRR) of Republic Act No. 12009. Copy of the minutes hereto attached as **Annex B**;

**WHEREAS**, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 22 May 2025, Copy of PhilGeps postings hereto attached as **Annex C**;

**WHEREAS**, the Request for Quotation (RFQ) was sent to the following:

**WHEREAS**, during the opening of the sealed quotations held on 28 May 2025 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

**WHEREAS**, the end-user evaluation report submitted on 04 June 2025 disclosed that WIRELESS LINK TECHNOLOGIES INC. complied with all CAAP requirements and specifications and is considered the lowest calculated and responsive quotation. Copy of the Evaluation hereto attached as **Annex D**;

**WHEREAS**, Section 34, Subsection 34.3, Paragraph (g) of the Implementing Rules and Regulations of Republic Act No. 12009 provides that: "The Bids and Awards Committee (BAC) shall recommend to the Head of the Procuring Entity (HoPE) the award of contract in favor of the supplier, contractor, or consultant with the Lowest Calculated and Responsive Bid (LCRB), Most Economically Advantageous Responsive Bid (MEARB), Most Advantageous Responsive Bid (MARB). Or Highest Rated Responsive Bid (HRRB), as applicable."

**NOW, THEREFORE**, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby **RESOLVED** to recommend for **APPROVAL** of the Supply and Delivery of Handheld Tunable Radio in the total amount of **TWO HUNDRED SIXTY-EIGHT THOUSAND EIGHT HUNDRED PESOS (P268,800.00)** only, and be **AWARDED** to **WIRELESS LINK TECHNOLOGIES INC**, the offer of which was considered reasonable and advantageous to the Government;
