



CCC Resolution No. 2025-016

SUBJECT: SUPPLY AND DELIVERY OF INDUSTRIAL DIGITAL MULTIMETER FOR VARIOUS ANFs.

WHEREAS, Purchase Request/POW/CBA No. 25-04-531 dated 22 April 2025 for the Supply and Delivery of Industrial Digital Multimeter for various ANFs with a total budget of 298,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 16 May 2025, the Civil Aviation Authority of the Philippines – Contract and Canvass Committee (CAAP-CCC) resolved to procure this project through Small Value Procurement (SVP) in accordance with Section 34 of the Implementing Rules and Regulations (IRR) of Republic Act No. 12009. Copy of the minutes hereto attached as **Annex B**;

WHEREAS, the Request for Quotation (RFQ) was first posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 22 May 2025, two (2) quotations were received by the CCC Secretariat but was disqualified due to non compliance in the documentary requirements. The project was re-posted on 01 June 2025, Copy of PhilGeps postings hereto attached as **Annex C**;

WHEREAS, the Request for Quotation (RFQ) was sent to the following:

1. ABELTRADE ENTERPRISES CORPORATION;
2. ACCESS FRONTIER TECHNOLOGIES, INC.;
3. METOS OFFSHORE INC.;
4. C.A.T.S SAFETY DEVICE TRADING;
5. PRESIDIUM PH CORPORATION;
6. SERVICE PLUS CORPORATION; and
7. ULY TECH TRADING

WHEREAS, during the opening of the sealed quotation held on 05 June 2025 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

Supplier	Price Quotation
1. ACCESS FRONTIER TECHNOLOGIES INC.	P283,064.32

WHEREAS, the end-user evaluation report submitted on 11 June 2025 disclosed that ACCESS FRONTIER TECHNOLOGIES INC. complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as **Annex D**;

WHEREAS, Section 34, Subsection 34.3, Paragraph (g) of the Implementing Rules and Regulations of Republic Act No. 12009 provides that: *"The Bids and Awards Committee (BAC) shall recommend to the Head of the Procuring Entity (HoPE) the award of contract in favor of the supplier, contractor, or consultant with the Lowest Calculated and Responsive Bid (LCRB), Most Economically Advantageous Responsive Bid (MEARB), Most Advantageous Responsive Bid (MARB). Or Highest Rated Responsive Bid (HRRB), as applicable."*

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby **RESOLVED** to recommend for **APPROVAL** of the Supply and Delivery of Industrial Digital Multimeter for various ANFs in the total amount of **TWO HUNDRED EIGHTY-THREE THOUSAND SIXTY-FOUR AND 32/100 PESOS (283,064.32)** only, be **AWARDED** to **ACCESS FRONTIER TECHNOLOGIES INC.** the offer of which was considered reasonable and advantageous to the Government;
