



CCC Resolution No. 2025-025

"RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF JANITORIAL SUPPLIES FOR FMD-BGMS FACILITY CLEANER AT CAAP HEAD OFFICE THROUGH SMALL VALUE PROCUREMENT UNDER SECTION 34 OF THE IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 12009"

WHEREAS, Deputy Director General for Administration, Atty. Danjun G. Lucas, has approved the Purchase Request for the Procurement of Janitorial Supplies for FMD-BGMS Facility Cleaner at CAAP Head Office in accordance with CBA No. 25-05-605 dated 06 May 2025 with a total budget allocation of P496,350.00. The approval is documented and attached hereto as **Annex A**, which forms as integral part of this Resolution;

WHEREAS, some items listed in the approved Purchase Request were available at the Supply Division, consequently, the total approved budget for the contract was reduced from Php496,350.00 to Php483,850.00;

WHEREAS, on 27 June 2025, the Civil Aviation Authority of the Philippines – Contract and Canvass Committee (CAAP-CCC) resolved to procure this project through Small Value Procurement (SVP) pursuant to Section 34 of the Implementing Rules and Regulations (IRR) of Republic Act No. 12009. Copy of the minutes hereto attached as **Annex B**;

WHEREAS, CAAP-CCC, through its Secretariat, posted the Request for Quotation (RFQ) on the Philippine Government Electronic Procurement System (PhilGEPS), the CAAP website, and in conspicuous locations within CAAP premises on 01 July 2025. A copy of the PhilGEPS postings is hereto attached as **Annex C**;

WHEREAS, the Request for Quotation (RFQ) was sent to the following:

1. VICTORIA CHEMICAL INDUSTRIES, INC.;
2. MAITRE-D INDUSTRIAL SALES CORPORATION;
3. POWERCLEAN SOLUTIONS;
4. BONITA TISSUE CLEAN CORPORATION;
5. BEEMAX CONSUMER GOODS TRADING; and
6. ENC ENTERPRISES;

WHEREAS, during the opening of the sealed quotation held on 04 July 2025 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

WHEREAS, the end-user evaluation report submitted on 11 July 2025 disclosed that MAITRE-D INDUSTRIAL SALES CORPORATION complied with all CAAP requirements and specifications, and was determined to be the lowest calculated and responsive quotation. A copy of the evaluation report is hereto attached as **Annex D**;

WHEREAS, Section 34, Subsection 34.3, Paragraph (g) of the Implementing Rules and Regulations of Republic Act No. 12009 provides that: *"The Bids and Awards Committee (BAC) shall recommend to the Head of the Procuring Entity (HoPE) the award of contract in favor of the supplier, contractor, or consultant with the Lowest Calculated and Responsive Bid (LCRB), Most Economically Advantageous Responsive Bid (MEARB), Most Advantageous Responsive Bid (MARB). Or Highest Rated Responsive Bid (HRRB), as applicable."*

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby **RESOLVED** to recommend for **APPROVAL** of the Procurement of Janitorial Supplies for FMD-BGMS Facility Cleaner at CAAP Head Office in the total amount of **THREE HUNDRED EIGHTY-FOUR THOUSAND FIFTY PESOS (P384,050.00)** only, and be **AWARDED** to **MAITRE-D INDUSTRIAL SALES CORPORATION.**, the offer of which was considered reasonable and advantageous to the Government;
