



**CCC Resolution No. 2025-032**

**“RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF CARPENTRY MATERIALS FOR AIR NAVIGATION FACILITIES THROUGH SMALL VALUE PROCUREMENT UNDER SECTION 34 OF THE IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 12009”**

**WHEREAS**, Deputy Director General for Administration, Atty. Danjun G. Lucas, has approved the Purchase Request for the Supply and Delivery of Carpentry Materials for Air Navigation Facilities in accordance with CBA No. 25-04-473 dated 10 April 2025 with a total budget allocation of P79,385.60. The approval is documented and attached hereto as **Annex A**, which forms as integral part of this Resolution;

**WHEREAS**, BAC Bravo recommended for the change of mode of procurement and subsequently approved by the Head of Procuring Entity (HoPE) through BAC Resolution No. 2025-0311-34 dated 10 June 2025. Copy of Resolution hereto attached as **Annex B**;

**WHEREAS**, on 02 July 2025, the Civil Aviation Authority of the Philippines – Contract and Canvass Committee (CAAP-CCC) agreed to procure this project through Small Value Procurement (SVP) pursuant to Section 34 of the Implementing Rules and Regulations (IRR) of Republic Act No. 12009.
