



**Contract Agreement For**

**COURIER SERVICE FOR THE DELIVERY/HAULING EQUIPMENT, PARTS, MATERIALS, AND OTHER ACCESSORIES, INCLUDING DOCUMENTS OF VARIOUS CNS, MET, & ELECTRO-MECHANICAL FACILITIES.**

**THIS AGREEMENT** made the SEP 16 2025 between **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP)** with office address at Old MIA Road corner Ninoy Aquino Avenue, Pasay City 1300. (hereinafter called "the Entity") of the one part and **LIBCAP SUPER EXPRESS CORPORATION.** with office address at LIBCAP Bldg., Quintin Salas Jaro, Iloilo City (hereinafter called "the Supplier") of the other part;

**WHEREAS,** the Entity invited Bids for certain goods and ancillary services, particularly, **Contract No. G-2025-062: Courier Service for the Delivery/Hauling Equipment, Parts, Materials, and Other Accessories, including Documents of Various CNS, MET, & Electro-Mechanical Facilities** and has accepted a bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION FOUR HUNDRED FIFTY-NINE THOUSAND EIGHTY PESOS (PHP 1,459,080.00) ONLY** (hereinafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - ii. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - iii. Other contract documents that may be required by existing laws and/or the Procuring Entity. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the**

contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **ONE MILLION FOUR HUNDRED FIFTY-NINE THOUSAND EIGHTY PESOS (PHP 1,459,080.00) ONLY** or such other sums as may be ascertained, **LIBCAP SUPER EXPRESS CORPORATION** agrees to deliver *Contract No. G-2025-062: Courier Service for the Delivery/Hauling Equipment, Parts, Materials, and Other Accessories, including Documents of Various CNS, MET, & Electro-Mechanical Facilities within One (1) year from receipt of Notice to Proceed* in accordance with his/her/its Bid.
4. The **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.





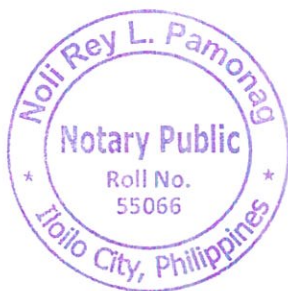
