In case of two or more bidders are determined to have submitted the Lowest Calculated Quotation/Lowest Calculated and Responsive Quotation, CAAP Area Center III shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.



## **SCOPE OF WORK**

### **I. GENERAL**

The works to be accomplished by the successful bidder shall consist of furnishing, supervision, labor, materials, supplies, tools, and equipment to complete the **Replacement of Main Gate at San Jose Airport.**

### **II. LOCATION OF PROJECT**

The Contract to be bid is located at **San Jose Airport, San Jose, Occidental, Mindoro.**

### **III. SCOPE OF WORK**

The details of work are at best enumerated below, but be noted that the Contract includes all works and services although not specifically mentioned herein, but are needed to fully complete the Project.

The Project covers the supply of labor, materials, mobilization/demobilization, tools/equipment, necessary for **Replacement of Main Gate at San Jose Airport** with the following scope of works which shall be done in accordance with the approved plans, specifications and provision of contract to wit: (Work shall include but is not limited to the following);

#### **1. Mobilization / Demobilization**

This work includes mobilization and demobilization of the contractor's forces and equipment necessary for performing the work required under the contract.

- a. Mobilization shall include all activities and associated costs for transportation of contractor's personnel, equipment, and operating supplies to the site; establishment of offices, buildings and other necessary general facilities for the contractor's operations at the site.
- b. Demobilization shall include the disassembly, hauling/removal of debris/rubbish, and site clean-up of offices, buildings and other facilities assembled on the site.

**2. CIVIL/STRUCTURAL WORKS**

**2.1. Earthworks and/or Removal Works**

The work includes labor, materials, minor tools, and equipment to complete the Earthworks and/or Removal works (see annex A), as indicated on the program of work. (Workmanship must be approved by the Project-In-Charge assigned by CAAP).

**2.2. Concrete Works**

The work includes labor, materials, minor tools, and equipment to complete the Concrete works of Replacement of Main Gate. All concrete mix ratio should be M25 (1:2:4) and undergo concrete curing for at least 7 days, a slump test and a compressive strength test result is required to ensure that the concrete mix ratio is met, as indicated on the program of work. (Workmanship must be approved by the Project-In-Charge assigned by CAAP).



### **2.3. Steel Works**

The work includes labor, materials, minor tools, and equipment to complete the Steel Works of Replacement of Main Gate, including the framing of canopy, fabrication of main gate (see schedule of doors) and fabrication of "SAN JOSE AIRPORT" cut-out letters, as indicated on the program of work. (Workmanship must be approved by the Project-In-Charge assigned by CAAP).

## **3. ARCHITECTURAL WORKS**

### **3.1. Painting Works**

The work includes labor, materials, minor tools, and equipment to complete the Painting Works of Replacement of Main Gate, including painting of finished concrete works and fabricated gate, as indicated on the program of work. (Workmanship must be approved by the Project-In-Charge assigned by CAAP).

### **3.2. Gate wall**

The work includes labor, materials, minor tools, and equipment to complete the Gate Wall of Replacement of Main Gate, as indicated on the program of work. (Workmanship must be approved by the Project-In-Charge assigned by CAAP).

### **3.3. Canopy**
