SUBJECT: PREVENTIVE MAINTENANCE OF SERVICE VEHICLE FOR LAOAG INTERNATIONAL AIRPORT: PMS OF TOYOTA HI-ACE 2.8 GL GRANDIA TOURER A/T 2T WITH PLATE NUMBER SAC 1478 (AMBULANCE)

WHEREAS, the Head of the Procuring Entity, Area I, endorsed to the Bids and Awards Committee - Area I, the above-stated project with an estimated cost amounting to **Eight Thousand Four Hundred Thirty-Five Pesos and Fifteen Centavos Only (PhP8,435.15)**.

WHEREAS, based on the updated records of the BAC Area I, Toyota Ilocos Norte has submitted its updated Certificate of PhilGEPS Registration (Platinum Membership), 2025 Business Permit and Certification that Toyota Ilocos Norte, a branch of Toyota Dagupan City, Inc.) is the distributor of Toyota vehicle, genuine parts, accessories and quality service in Northern Luzon.

WHEREAS, Toyota Ilocos Norte submitted its proposal, quoted the needed supplies amounting to **Eight Thousand Four Hundred Thirty-Five Pesos and Fifteen Centavos Only (PhP8,435.15)**. A copy of the price quotation is attached for reference.

WHEREAS, Section 31 of IRR of RA 12009, states that *"Direct Contracting is a mode of procurement of Goods that does not require elaborate Bidding Documents, and the supplier is only required to submit at a price quotation of a pro-porma invoice together with the conditions of sale, which may be accepted immediately or after some negotiations"*.

NOW, THEREFORE, for and in consideration from the above premises, the BAC Area I **RESOLVES**, as it is hereby **RESOLVED**, to recommend for **APPROVAL** of this procurement to **TOYOTA ILOCOS NORTE** in the total amount of **EIGHT THOUSAND FOUR HUNDRED THIRTY-FIVE PESOS AND FIFTEEN CENTAVOS ONLY (PhP8,435.15)**, the offer of which was considered reasonable and advantageous to the Government.
