1. Bidders shall provide correct and accurate information required in this form.
2. Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
3. Price quotation/s must be valid for a period of thirty (30) calendar days from the deadline of submission.
4. Price quotation/s, to be denominated in Philippine peso, shall include all taxes, duties, and/or levies payable.
5. Quotations exceeding the Approved Budget for the Contract shall be rejected.
6. In case of two or more bidders are determined to have submitted the Lowest Calculated Quotation/Lowest Calculated and Responsive Quotation, CAAP Area Center III shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.
7. Award of contract shall be made to the lowest quotation which complies with the technical specifications, requirements and other terms and conditions stated herein.
8. The item/s shall be delivered according to the accepted offer of the bidder.
9. Item/s delivered shall be inspected on the scheduled date and time of the CAAP Area Center III. The delivery of the item/s shall be acknowledged upon the delivery to confirm compliance with the technical specifications
10. Payment shall be made after delivery and upon the submission of the required supporting documents, i.e., Order Slip and/or Billing statement, by the supplier, contractor, or consultant. ## **SCOPE OF WORK**

### **I. General**

The works to be accomplished by the successful bidder shall consist of furnishing, supervision, labor, materials, supplies, tools, and equipment to complete the **Vegetation Control at Plaridel Airport.**

### **II. LOCATION OF THE PROJECT**

The Contract to be bid is located at **Plaridel Airport, Plaridel, Bulacan**

### **III. Scope of Work for Vegetation Control**

#### **A. Objective**

The purpose of this scope of work is to outline the tasks required for the effective removal and control of unwanted vegetation, including grass, brush, trees, and other plant growth, within designated areas of Plaridel Airport. The objective is to maintain safety, ensure unobstructed visibility, and preserve the structural integrity of airport facilities.

#### **B. Areas Covered**

Vegetation control shall be performed in the following areas:

- **Runway Shoulders:** Approximately 57,002.78 square meters surrounding the runway, primarily for the control and removal of small grass.
- **Perimeter Fence Line:** Approximately 3980.83 square meters for the clearing of trees, brush, and shrubs.
- **Other Designated Grounds:** Additional areas, as identified by airport management, within the total covered area of 60,983.61 square meters for general vegetation control.

#### **C. Scope of Services**

The contractor shall perform the following services:

- **Grass Cutting and Trimming:** Regular cutting of grass in designated areas to maintain a height compliant with airport safety standards.

- **Brush and Tree Removal:** Clearing of overgrown brush, small trees, and shrubs, especially along the perimeter fence and around navigational equipment.
- **Debris Removal:** All vegetation debris, including cut grass, uprooted plants, branches, and other organic matter, shall be collected and properly disposed of off-site.
- **Maintenance of Clear Zones:** Ensuring that no vegetation obstructs runways, taxiways, signage, or fences.

#### **Contractor Responsibilities**

- Provide all necessary labor, tools, equipment, and materials.
- Ensure all activities comply with airport safety regulations and environmental standards.
- Coordinate with airport operations to avoid disruption to flight activities.
- Remove and dispose of all accumulated vegetation and debris from the site promptly after each maintenance activity.
