1. Bidders shall provide correct and accurate information required in this form.
2. Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
3. Price quotation/s must be valid for a period of thirty (30) calendar days from the deadline of submission.
4. Price quotation/s, to be denominated in Philippine peso, shall include all taxes, duties, and/or levies payable.
5. Quotations exceeding the Approved Budget for the Contract shall be rejected.
6. In case of two or more bidders are determined to have submitted the Lowest Calculated Quotation/Lowest Calculated and Responsive Quotation, CAAP Area Center III shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.
7. Award of contract shall be made to the lowest quotation which complies with the technical specifications, requirements and other terms and conditions stated herein.
8. The item/s shall be delivered according to the accepted offer of the bidder.
9. Item/s delivered shall be inspected on the scheduled date and time of the CAAP Area Center III. The delivery of the item/s shall be acknowledged upon the delivery to confirm compliance with the technical specifications



SCOPE OF WORK

I. GENERAL

The works to be accomplished by the successful bidder shall consist of furnishing, supervision, labor, materials, supplies, tools and equipment to complete the **Repair of Powerplant Buildings at Jomalig Airport**.

II. LOCATION OF PROJECT

The Contract to be bid is located at **Jomalig Airport, Mamburao, Jomalig, Quezon**.

III. SCOPE OF WORK

The details of work are at best enumerated below, but be noted that the Contract includes all works and services although not specifically mentioned herein, but are needed to fully complete the Project.

The Project covers the supply of labor, materials, mobilization/demobilization, tools/equipment, necessary for **Repair of Powerplant Buildings at Jomalig Airport** with the following scope of works which shall be done in accordance with the approved plans, specifications and provision of contract to wit: (Work shall include but is not limited to the following);

1. Mobilization / Demobilization

This work includes mobilization and demobilization of the contractor's forces and equipment necessary for performing the work required under the contract.

- a. Mobilization shall include all activities and associated costs for transportation of contractor's personnel, equipment, and operating supplies to the site; establishment of offices, buildings and other necessary general facilities for the contractor's operations at the site.
- b. Demobilization shall include the disassembly, hauling/removal of debris/rubbish, and site clean-up of offices, buildings and other facilities assembled on the site.



c. **Project Information Sign**

The contractor shall provide temporary construction of Project information signage. (Location shall be coordinated with the Project-In-Charge assigned by CAAP).

In accordance with the COA Circular No. 2013-004 dated January 30, 2013. To promote good governance through transparency and accountability, infrastructure projects shall have a tarpaulin signboard, suitability framed for outdoor display at the project location, and shall have the following specifications:

- a. White, 8ft by 8ft in size
- b. Resolution: 70 dpi
- c. Font: Helvetica
- d. Font Size: Main Information- 3"; Sub Information-1"
- e. Font Color: Black"

2. Waterproofing Works

a. Preparation of Substrate

The work includes all labor and minor tools for the cleaning and clearing the substrate prior to the application of the four-coat cementitious waterproofing. The area must be kept free from any dust, dirt, and foreign materials that might affect the performance of the waterproofing materials to be applied. (The surface must be inspected and approved by the Project-In-Charge assigned by CAAP).

b. Application of Cementitious Waterproofing

The work includes all labor, materials, and minor tools for the application of the four-coat cementitious waterproofing.

A ratio of 7.5 kg of sieved Portland cement shall be mixed with every gallon of cementitious waterproofing. The mixture shall be stirred thoroughly to avoid clumping of materials before the application. There shall have a two-hour interval on each coat to ensure that the previous coat is already dried before the application of new coat (a total of 4 coats). Waterproofing fiber mesh shall be applied in joints and cracks and coated with cementitious waterproofing. (Workmanship must be approved by the Project-In-Charge assigned by CAAP).



d. Flood Test

The work includes labor and minor tools to conduct flood test. This shall be conducted succeeding the application of cementitious waterproofing. The slab must be immersed in water at the depth of 5cm to 10cm for at least 24 hours to check for leaks. (This item must be inspected and approved by the Project-In-Charge assigned by CAAP).

All scope of work to this item must be according to the approved plan and specifications. Quality and types of materials must conform and approved by the Project Engineer assigned by CAAP.

The contractor shall be responsible in providing the personal protective equipment (PPE) for staffs and workers, and Safety Inspectors or Safety Engineers on site while construction is ongoing. Regular safety reports shall be reported.

The contractor shall be responsible for all laboratory, material testing, environmental compliance certificate (ECC), building and safety permits and survey instruments necessary in the project implementation (if needed). All expenses shall be incorporated in the contractor's overhead cost and shall not be considered as pay item.
