SUBJECT: SUPPLY AND DELIVERY OF VARIOUS APPLIANCES FOR CAAP AREA I

WHEREAS, the Head of the Procuring Entity, Area I, endorsed to the Bids and Awards Committee Area Center I the procurement of the above-mentioned project.

WHEREAS, the BAC Area Center I, through its Secretariat with the help of the TWG, has undertaken the required procurement activities relative to the above-mentioned project.

WHEREAS, the supplier is capable to meet the Single Calculated Quotation (SCQ) for each item as shown in the attached Abstract of Quotations with the highlighted bid price/offer getting the SCQ.

WHEREAS, based on the updated records of BAC Area I, the lone supplier is capable to meet the minimum requirements set forth by RA 9184 and its updated IRR. And upon validation, they can comply with the terms and conditions imposed herein for the supply and delivery of the goods.

NOW, THEREFORE, on the basis of the foregoing, it is hereby **RESOLVED** that:

- a) **LB2 LABORATORY SUPPLIES** is the supplier having the Single Calculated and Responsive Quotation (SCRQ) for Items No. 4, 5, 7 and 8;
- b) **FAILURE OF BIDDING** for Item/s No. 1, 3, 6, 9, 10, and 12 for no bids are received for there is no RFQ received and in compliance with the provisions of RA 12009 and its IRR, the BAC shall direct the End-User to conduct a mandatory review and evaluation of the terms, conditions and specifications of the Program of Work, including its cost estimates;
- c) **FAILURE OF BIDDING** for Item/s No. 2, 11, and 13 for no bid qualifies as SCRB, MARB, LCRB, HRRB or MEARB and in compliance with the provisions of RA 12009 and its IRR, the BAC shall direct the End-User to conduct a mandatory review and evaluation of the terms, conditions and specifications of the Program of Work, including its cost estimates;
- d) To recommend approval to the Civil Aviation Area Manager of Laoag International Airport the foregoing findings.
