SUBJECT: SUPPLY AND DELIVERY OF VARIOUS TOOLS, EQUIPMENT AND OTHER SUPPLIES FOR USE OF THE DIFFERENT AIRPORTS OF CAAP AREA CENTER I

WHEREAS, the Head of the Procuring Entity, Area I, endorsed to the Bids and Awards Committee Area Center I the procurement of the above-mentioned project.

WHEREAS, the BAC Area Center I, through its Secretariat with the help of the TWG, has undertaken the required procurement activities relative to the above-mentioned project.

WHEREAS, the supplier is capable to meet the Lowest Calculated Quotation (LCQ) for each item as shown in the attached Abstract of Quotations with the highlighted bid price/offer getting the LCQ.

NOW, THEREFORE, on the basis of the foregoing, it is hereby **RESOLVED** that:

- a) **LAOAG NEWTON CONSTRUCTION SUPPLY** is the supplier having the Lowest Calculated and Responsive Quotation (LCRQ) for Items No. 2, 10, 12 and 13;
- b) **ECD ENTERPRISES** is the supplier having the Lowest Calculated and Responsive Quotation (LCRQ) for Items No. 1, 3, 4, 5, 7, 8, 9, 11, 14, 15 and 16;
- c) **FAILURE OF BIDDING** for Item/s No. 6 for no bid qualifies as SCRB, MARB, LCRB, HRRB or MEARB and in compliance with the provisions of RA 12009 and its IRR, the BAC shall direct the End-User to conduct a mandatory review and evaluation of the terms, conditions and specifications of the Program of Work, including its cost estimates
- d) To recommend approval to the Civil Aviation Area Manager of Laoag International Airport the foregoing findings.
